



## COMMITTEES

- *Implementation* - overseeing the open-source SCION implementation and its roadmap and governing the source code repositories <https://github.com/scionproto>
- *Standardization* - governing the overall direction of the SCION specifications and the evolution of the SCION protocol. It also coordinates the standardization efforts, including within external SDOs as the IETF
- *Adoption* - providing expertise and direction on matters relating to SCION deployment
- *Marketing* - coordinating and ensuring alignment of marketing and communication activities around the SCION technology.

# ABOUT SCION ASSOCIATION AND ANAPAYA SYSTEMS AG

The SCION Association was formed in August 2022 by ETH Zurich and other founding members. Professors Adrian Perrig, David Basin and Peter Müller from ETH Zurich who conduct research in the field of SCION are co-founders, shareholders and board members of Anapaya Systems AG. These professors do not assume any functions in any body of SCION Association, except for Adrian Perrig who chairs its Advisory Board in a non-executive capacity (the Advisory Board has no voting rights or authority to issue instructions).

In order to exercise technical supervision over the SCION reference open source implementation (code governance), SCION Association has taken over the administration of the open-source code exclusively. Anapaya Systems AG has transferred the administration of the GitHub repository to the SCION Association.

In March 2023 Anapaya Systems AG joined SCION Association as a regular member. As for other members members, employees of Anapaya participate into the Association's committees, to collaborate on topics such as open source, standardization, marketing and adoption.

As of November 2023, the CEO of Anapaya Systems AG, Martin Bosshardt, is a member of the Advisory Board of SCION Association.

The Board of Directors of SCION Association is aware of potential conflicts of interest and all business relations with Anapaya Systems AG are strictly at arm's length.
